1 Name of regulation

This regulation is the *Superannuation (Unclaimed Money and Lost Members) Amendment Regulation 2012 (No.).*

2 Commencement

This regulation commences on the day after it is registered.

3 Amendment of Superannuation (Unclaimed Money and Lost Members) Regulations 1999
